**Arising:** Fire Training Grounds Proposal

Fire Department Members are in agreement that the location beside the Department of Highways Depot is the best option to try to obtain for their training grounds as there is an existing fire hydrant and cell phone service

in that area.

Fire Training Grounds is the first choice for the Fire Department 2024 Budget. If that is not possible, the prioritized list provided will be considered.

# FD Junior's Fund Raising/Donations

Members were in agreement that the request for the Junior Firefighters to fundraise through selling cookie dough be approved as presented. They must be transparent and inform the public what they are fundraising for. All future fundraising must still be submitted to council for approval to ensure all applicable rules relating to that particular fundraiser are in place.

The letter requesting monetary donations to cover the cost of equipment and training materials is not approved as the town covers the cost of all supplies and equipment required to provide the Junior Firefighters with adequate training.

### **Possible Water Leak**

The water leak is not in the main waterline. The town will ask for assistance from the Dept. of Transportation and Works to rectify the problem if source of the leak can't be determined.
